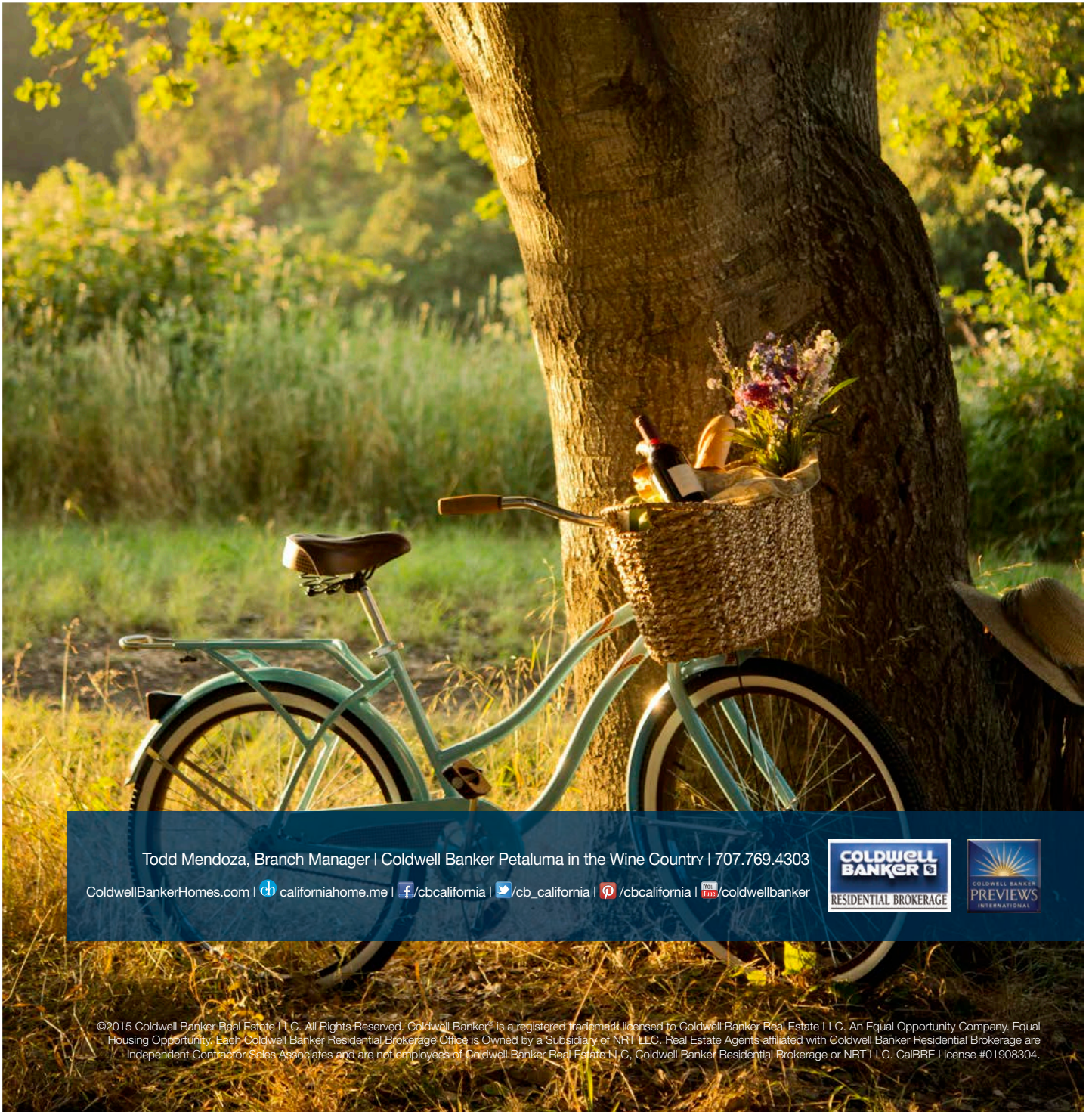

# Memories

During the 60's and 70's, we as a family vacationed in Eagle River Wisconsin. We had a vacation home on Cranberry Lake on the Eagle River Chain of 27 lakes. The father's all worked during the week and on the weekends the father's would all show up Friday around cocktail time to take the wife's out to dinner.

The number one thing for kids to do around 5 pm – 6 pm was go water skiing. The wind was calm and the water flat. Parents would sit on the dock with their cocktails and watch the kid's water ski.

Any parent on the dock was considered open game for kid's water skiing.

This one particular weekend my parents had invited Owen Olms and his wife to the cottage from Chicago for the weekend. My brother Craig was taking me water skiing so the Olms's could see how the whole water skiing thing worked. While we were out skiing I could see that my mother and Mrs. Olms had sat down on the chaise lounge chairs on the dock and my father and Mr Olms were standing on the dock gangway. My father knew to never go on the dock when kids were skiing. While I was skiing, I motioned to my brother Craig, pointing to the dock that there were parents on the dock. He knew what that meant. Drive the ski boat past the dock so that Mac can spray the dock with water and hopefully get one or more slow moving parents.

My father and Mr. Olms were in a coat and tie. My mother and Mrs. Olms had both been to the beauty parlor that day getting their hair done and had pretty dresses on.

As we approached the dock, I can see my father saying something to Mr. Olms. They both quickly walked off the dock and on to land. I can then see my father yell something to my mother Itsy who is on the dock with Mrs. Olms on chaise lounges.

My mother's head spins around and she sees me coming at them. My mother jumps up out of her chair, runs off the dock and as she is running she is yelling at Mrs. Olms, run, run, here comes Mac. Mrs. Olms had no idea what was happening. Absolutely no idea. She stands up and smiles as if saying, Wow, this is great.

I blanket the whole dock with water from my slalom



ski. Mrs. Olms looked like a drown rat. Needless to say I did not get out of the water for a while. My father was laughing and my mother was shaking her fist at me.

My younger sister Heather Hakanen remembers it this way.

*Oh how I remember this whole scene vividly. I was on the dock with Mom and Mrs Olms. Likely 1971 or there about.*

*This was in the day and age where people "dressed" for cocktails more formally--even at a summer home. The ladies hair used a ton of Aqua-net to keep it lacquered in place and they wore snappy cocktail outfits. In those days, McKenzie could CRANK the spray of water and control how big (or small) he wanted that spray with accuracy using the red concave water ski (if memory serves accurately). The entire big dock where the chaise lounges were placed was completely saturated. And so was Mrs. Olms. I ran off the dock when I saw the boat and McKenzie start to push down on the ski to create the spray of water. My eyes couldn't believe what was coming because--this was cocktails for the parents! I knew what was coming and got the heck off the dock.*

*Itsy was SO pissed at McKenzie--he probably had to disappear down the shore for several days afterwards to let her cool down. I remember Mom having to take Mrs. Olms into her hair dryer and try and restyle the hairdo. Let's just say, the hairdo rework didn't turn out so swell. Mrs. Olms was kind of in shock while under the hair dryer. I also think her clothing was soaking too. Dinner must have been fun that night!!*

# Karah Estates Tasting Evening



On April 17th we hosted Karah Vineyards at the club. Cellar Master Danny and Tasting Room Associate, Lynne were on hand to delight us with their sparkling Pét Nat a nickname for *petillant naturel*, a method of producing sparkling wine by bottling the wine during the primary, alcoholic fermentation to capture the carbon dioxide that is naturally released. This differs from wines like Champagne that undergo a second, bubble-producing fermentation. Also Danny and Lynne shared some of Karah's *Rosé of Pinot Noir*, a perfectly balanced Chardonnay and their elegant 2016 Estate Pinot Noir. All great wines for your next cruise out!

Karah Estates is located just off highway 101 at Cotati. Members are welcome to visit their tasting room which is open on Friday's, Saturday's and Sunday's.

A little known fact is that in 1976 the environmental artists, Christo and Jean Claude constructed the now famous piece of environmental art, "*Running Fence*," which was 24.5 miles of fence constructed of white nylon that ran from where Karah Estate now stands into the Pacific Ocean at Bodega Bay.

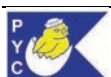

# From Tom's Galley

## Smoked Salmon Leek Chowder



*This is a simple, tasty recipe that can be prepared in less than an hour. Chop, slice and dice all ingredients before starting to cook. Then cooking is easy, just adding ingredients as needed in the recipe. This chowder tastes even better if made the day before and refrigerated over night where the flavors will marry and become more intense. Just reheat and serve. Enjoy, and please let me know what you think about these recipes: tom@cheztomas.com*

### Ingredients:

- ⚓ 3 tablespoons butter
- ⚓ 2 medium leeks, white and light green parts only, thinly sliced and rinsed (about 1 cup)
- ⚓ 1 large rib of celery, halved and sliced (about ½ cup)
- ⚓ ¼ cup flour
- ⚓ 1 cup milk
- ⚓ 2 8-ounce bottles clam juice
- ⚓ 3 small red potatoes, cut into ½ inch dice (about 2 ½ cups)
- ⚓ 2 bay leaves
- ⚓ 8 ounces smoked Sockeye Salmon (available at Trader Joe's)
- ⚓ 1 cup heavy cream
- ⚓ 2 tablespoons chopped fresh dill (or 1 tablespoon dried dill)
- ⚓ ½ cup sliced black olives

- ⚓ 1 tablespoon fresh lemon juice
- ⚓ 1 teaspoon Kosher salt
- ⚓ 15 grinds of pepper from a fresh pepper grinder (available at Trader Joe's)

*Option: Oyster crackers or toasted French bread as a garnish*

Prepare the leeks, celery, potatoes and dill and set aside.

Flake salmon into bite size pieces and set aside.

Melt butter in a 4- quart saucepan over medium heat.

Add leeks, celery and cook, stirring, until tender, about 6 minutes.

Add flour and cook, stirring for 1 minute.

Slowly whisk in milk and clam juice and bring to a simmer.

Add potatoes and bay leaves and simmer until potatoes are tender, about 12 minutes.

Add the salmon, cream, dill and lemon juice.

Cook until heated through.

Season to taste with salt and pepper.

Serve with Oyster crackers or toasted French bread.

This chowder can be prepared several hours in advance. Remove from heat, cover and let sit until ready to serve. Reheat until heated through and serve.

*These recipes have been created and developed by PYC member, Staff Commodore and chef Tom Griffith and are designed to be prepared on board your boat, using only two burners or a BBQ. They can also be prepared at home for any family dinner.*

# Sailing up the River

Matt called to say the *Shorleave* was ready and had to be brought up the Petaluma River from Richmond. *Shorleave*, a Roughwater 36 designed by Ed Monk, had just been serviced at KKMI and in the process renamed after Matt's grandfathers 70' cruiser that, among other things in it's illustrative life, had entertained Franklin and Eleanor Roosevelt and taken passengers up the Inland Passage to Alaska.

Matt had recently bought this new *Shorleave* in the hopes that it too will be available for charter in the Pacific Northwest, though right now he is planning on getting to know the boat, fix the inevitable little things that always need fixing, and sail around the north bay. It's new home, for now at least, is in the Petaluma Marina.

Heading out of the Richmond Harbor on this gray day, we turned northwards up to San Pablo Bay. We passed the East Brother Island Lighthouse, now a bed and breakfast, and Matt pointed out the Point San Pablo Bay Whaling Station, one of the last whaling stations in America which was active until 1971.

Despite the overcast skies the waters were flat and with the flooding tide we made the mouth of the river in 2 hours and passed the open Black Point railroad bridge.

It was striking for me, never having been up the river before, how wide it seemed as we wended our way past grazing sheep, cows and some fierce cattle dogs. Still it must have been quite a challenge in the early days of European settlement to sail up the river, or to navigate it at night as the regular ferries did in the early part of

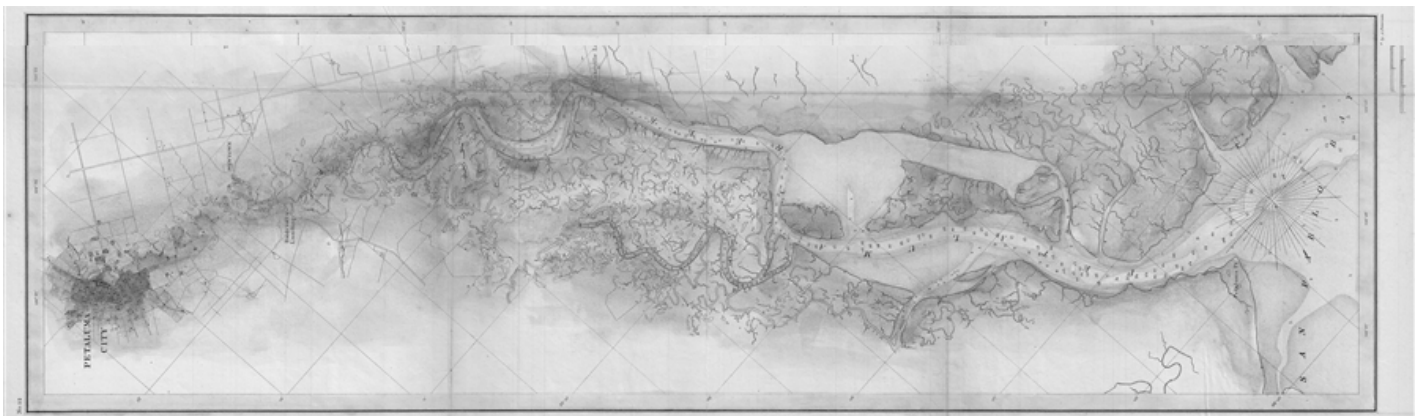


the last century.

In the early days the river was much more winding than now and many a journey consisted of the steamer traveling short distances and the captain having to stop and go as he went forward and back trying to navigate the turns in the creek. Many times the steamer hit ground and became stuck requiring the captain and crew and the passengers had to grab long poles and push the steamer off the land only to go a short distance further and then to repeat the process.

Our journey was much less dramatic and other than a few abandoned boats, some dodgy looking campers and a few afternoon walkers there was just us and the wild life to enjoy. As we slowed to minimize wake rounding Haystack landing, we noticed the many 'houses' perched half on the river some in need of some serious tender loving care.

Finally after four hours we arrived in the Petaluma Marina and berthed next to Tom Griffith's boat *Chez Tomas*. Well we were in good company!

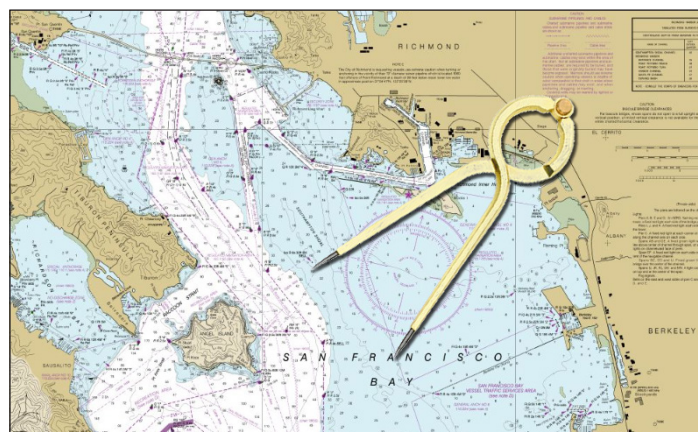

## TODD MENDOZA - *Commodore*

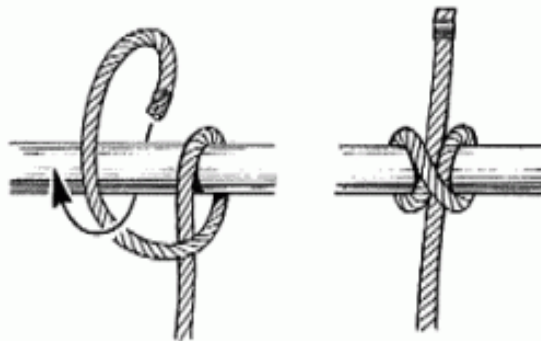
Ahoy!
