Some of you may have followed the story of the sailing ship *Matthew Turner*. In case you haven't, it was built over a period of several years, by volunteers in Sausalito, using traditional ship building construction techniques. The builders started with logs and a fully rigged tall ship emerged from the end of the process. It is patterned after a ship built in the Benicia shipyards of Matthew

Turner. Over his career, his yards built and launched 228 vessels. The replica was launched about a year ago. It is the first traditional, fully rigged tall ship launched in the bay area in over 100 years. It is 132 feet long and

displaces 175 tons. Since her launching, volunteers have been adding masts and rigging. Well, it is almost 100% complete. If you get a chance, stop by the Bay Model in Sausalito and marvel at this miracle of perseverance. It is berthed at the Corps of Engineers pier directly in front of the bay model. Once complete, it will be used by the Call of the Wild in their youth programs.

Call of the Sea is an educational nonprofit with the mission to inspire youth to unleash their potential through experiential, environmental education under sail. Their vision is to empower generations of students to become environmental stewards and

Notre Dame at PYC



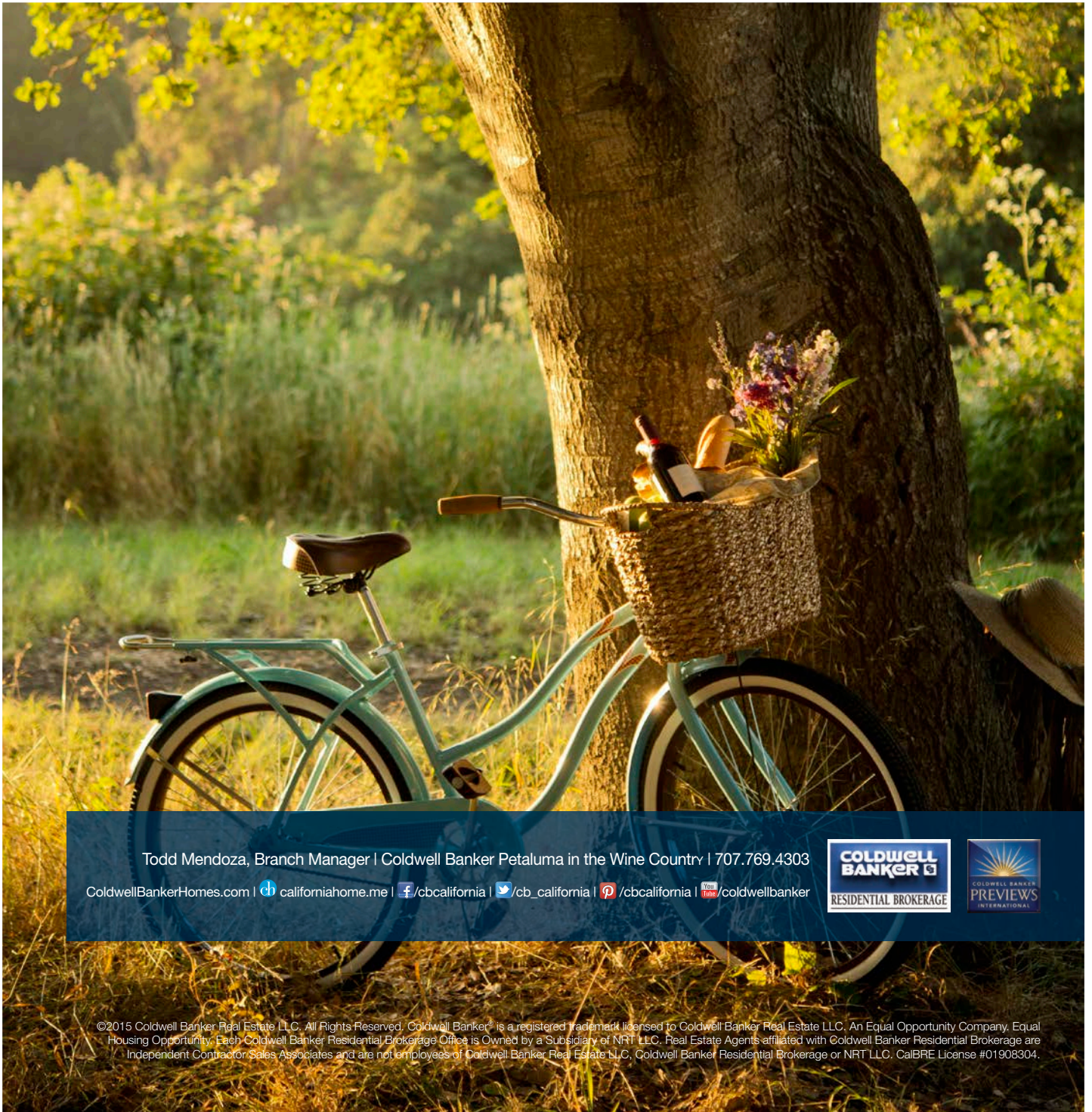

New Bridge - Public Comments

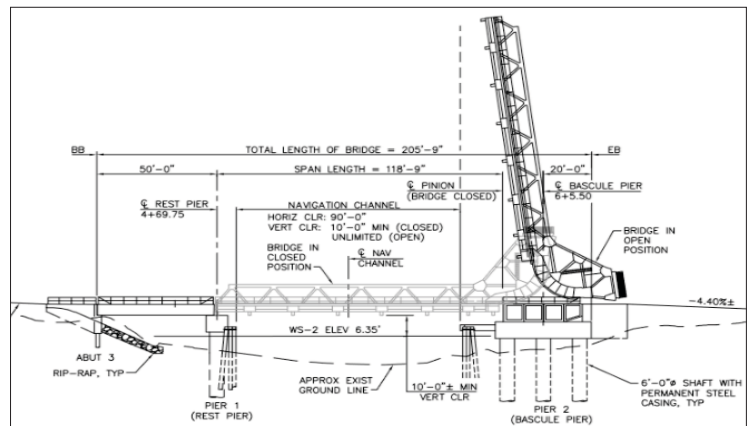
The City of Petaluma is proposing to construct a drawbridge upstream of the US 101 Highway Bridge and downstream of the D St Bridge over the Petaluma River at Caulfield Lane. As a United States Coast Guard Bridge Permit would be required for this project, the Coast Guard is requesting mariners to comment on navigational safety issues, including the need for pier protection, clearance gauges, hours of operation, and extent of nighttime navigation through the bridge.

On May 15th we hosted Mike Barber of Barber Cellars joined us for our May tasting series and graciously presented a sampling of his exquisite Pinot Gris, Chardonnay, and Zinfandel. Mike also shared details of his newly opened distillery, Barber Lee Spirits and teased members with a taste of his surprisingly mellow 100 proof Moonshine and Single Malt Rye Whiskey. Stop by the Distillery Barrel Room and sample a flight of spirits or imbibe in what Mike calls, the “best Manhattan cocktail in Petaluma!” The Corpse Reviver No. 2 is a close second. Barber Lee Spirits, located at 120 Washington Street is open Friday and Saturday from 12 pm to 7 pm but have plans to extend their hours this summer.

Barber Cellars tasting room is located at 112 Washington St. or accessible through the Hotel Petaluma lobby. They open at 12 pm daily and are closed Monday and Tuesday. Since his tasting room opens into the lobby of the Petaluma Hotel, he

boasts that the perfect way to spend a rainy evening (and we’ve certainly seen our fair share lately!) is to grab a glass, or better yet, a bottle and mosey into the hotel lobby, settle into a comfy sofa and enjoy the wood burning fireplace.

Corn Chile Salsa and Cheese Polenta



This polenta side dish is easy and can be made in a few minutes, yet the flavors blend into a creamy, cheesy polenta with a subtle corn flavor. This dish goes well with virtually any entrée from grilled steak to delicate sautéed fish filet. I even like it cold as a snack. Give it a try and let me know what you think.. Ingredients:

- ⚓ 1 - 18-ounce Trader Joe's Polenta chub
- ⚓ 1/4 cup milk
- ⚓ 1 - 13.75-ounce jar Trader Joe's Corn & Chile salsa
- ⚓ 1 - 8 ounce tub Trader Joe's Horseradish Pub Cheese
- ⚓ Kosher salt and Trader Joe's Rainbow Pepper grinder
- ⚓ Sour cream as a garnish (optional)

Method:

In a 10 inch skillet over medium heat, break up polenta.

Mash polenta with spatula or fork.

Add 1/4 cup milk and mix to incorporate.

Add the jar of Corn & Chile Salsa and mix well.

Add 8 ounces of Pub Cheese and mix until cheese is melted and mixture is smooth.

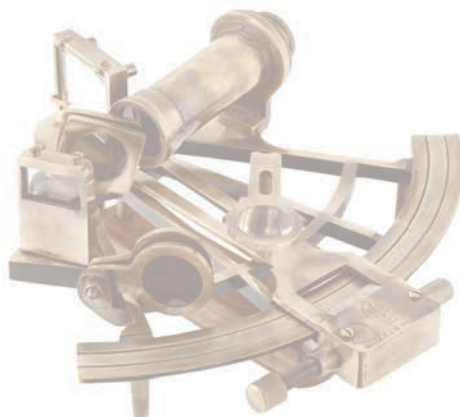
Season with Kosher salt and 12 grinds of pepper from a Trader Joe's Rainbow Pepper grinder.

Garnish with a dollop of sour cream if desired.

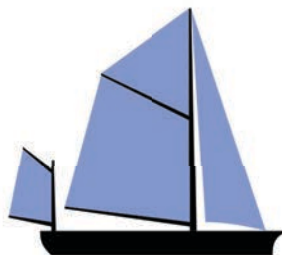

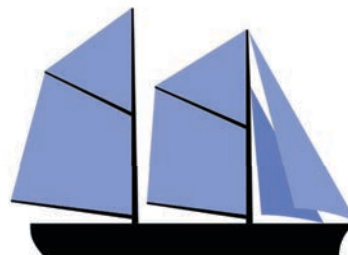

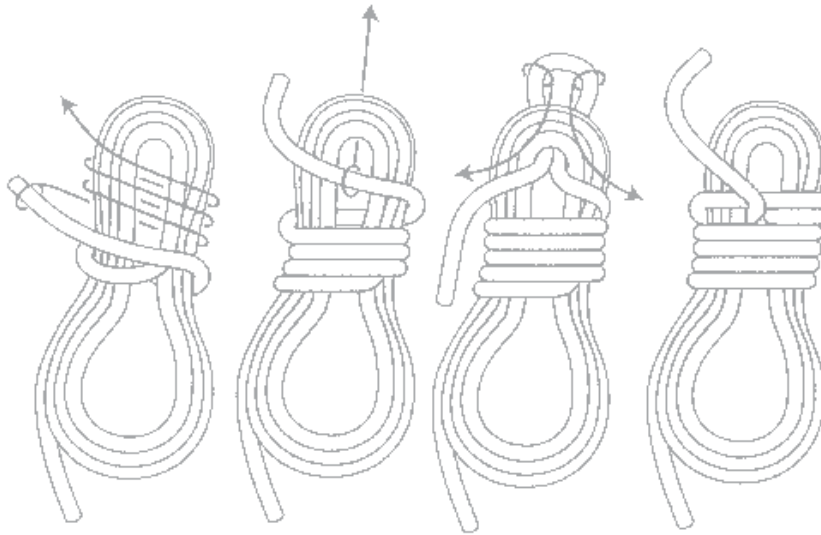
come by land and join the group at different ports.

I want to remind everyone that bar duty once a year is a requirement of membership in PYC. This year everyone has been signing up online and its gone fairly smooth. Now, however, as we are approaching the

summer months we have several holes in the schedule (*see below*) that need to be filled.

I will be sending out a reminder email to everyone who has not signed up in the next week or so and I would appreciate it if you sign up online by sending an email to pycinfo@petalumayachtclub.com with a subject of **Signup** for full details. I really don't want to have to call members who haven't signed up.

Secondly, I want to remind everyone who takes bar duty to be sure and fill out a bar tally form when you

open the bar on Friday night and when you close on Saturday. Use the deposit slips and envelopes in the cash box to prepare the deposit and put it in the slot at Bank of The West. Anything over \$200 should be deposited. The bar tally forms are in the binder next to the safe. It's very important that you indicate the starting cash total, ending total and deposit amount. The bar tally sheets are used to reconcile the bank deposits and if you don't fill one out the audit trail has been affected. Please fill one out for each weekend shift.

And lastly, the bar is technically open until the last patron leaves. But if its a slow night and only a hand full of people have come by, its not unreasonable for the on duty bartenders to fill out the deposit slip and leave after 8:00pm if there are just 2 or 3 people left. There must be at least one member in attendance, and the bar becomes an honor bar for the member who stays. Please don't abuse this rule. If there's a crowd at the bar, bar duty continues until the last person decides to go.
