## Delta Cruise - Wrap Up

The Delta Cruise concluded with Delta Yacht Club. Our club had a wonderful time as usual. I would like to take this opportunity to discuss something that happened that should serve as an example and help make our membership aware of something important we are missing that is lifesaving!

Most of you know my back ground. For those of you who are unaware I have been a licensed Paramedic for over twenty two years. This means I have seen the evolution of cardiac arrest saves improve dramatically over the last two decades. Why is this you ask? Citizens have better access to 911 directly vs CHP over cell phones, hands only CPR which a small child could even do has helped and having access to Automatic External Defibrillators in public locations have all made the difference.

Time makes the difference. So, what am I talking up when I am discussing the importance of time? Without oxygen being circulated through blood the brain can die after six minutes and the heart can die after ten

minutes or less. Obviously preventing brain death is the best chance for survival. I have been told by several members more senior to me about the liability the club could incur from having an AED (Automatic External Defibrillator) in the club and we are lucky Petaluma Fire Department has a station so close to us. Yeah, good luck on that one. In a perfect world Petaluma Fire Department would be in their station and not on another EMS run. When a call comes in the fire engine and Paramedic Ambulance respond together typically. The next fire engine and Paramedic Ambulance could be responding from the other side of town with a response that may exceed those six minutes. When 911 is called it may take up to a minute before the fire department is notified of the call and another thirty seconds plus before they are responding plus the travel time with lights and sirens before they make it in to initiate lifesaving measures. This is something our entire membership should be aware of. We have an extremely busy fire department with staffing levels based off of the population from the thirty years ago or more. Their call volume has increased drastically over the years. Despite this Petaluma Fire Department is excellent at what they do.

Cardiac Arrest does not discriminate with ages. I have seen the very young to the elderly fall victim to this from random genetic cardiac dysrhythmias to consequences from cardiac diseases. Having a defibrillator with basic hands on only CPR can make the difference. I bought one for my home and to take to the boat as needed. I am also concerned about my children and others getting shocked from stray current in the water as this can happen with poorly grounded and maintained boats. This happened years ago at Lake Sonoma to give you a local example.

Now that I have your attention I will tell you about our experience on the Delta Cruise and why this is so important to have an AED for our club and cruise outs. During the middle of our trip a boater on the cruise

experienced some cardiac symptoms. Beth Darrow (An ICU Nurse from Santa Rosa Memorial Hospital), was told initially by the boater's wife he thought he might be having a heart attack. Mike Freeman rushed over to my boat where I still had one eye open before my morning coffee told me what was going on and to get my AED. I quickly walked over and with one of my other devices confirmed his heart rate was 26 and weak. Beth found a blood pressure cuff and we determined his blood pressure was super low. Beth gave me a brief description of his symptoms. His symptoms improved laying down after we told him to lay down and not move for fear of sudden cardiac arrest.



Now, calling for resources to help was another issue. I tried to get them to send a medical helicopter (Paramedic & Registered Nurse). We were basically in the middle of nowhere where advanced life support could be awhile. We felt better having this AED with us just in case things went south. The address came up as a land location in Stockton and San Joaquin Sheriff's Marine Unit fortunately knew the location for Delta Yacht Club and arrived in about twenty minutes. They were EMTs which means basic life support

only. They were not Paramedics which is advanced life support. I told the SO officer our boater could not walk and we had to carry him due to a high risk of cardiac arrest. We carried him and laid him down in the back of the SO boat. Fortunately, the water was smooth. They were unable to take him to a levy due to the lower tide where Paramedics were waiting. We had to travel another ten minutes by water to a dock where the transfer was made. We still had my AED for the trip just in case. It took about thirty minutes before he received advanced life support care from the Paramedics.

You cannot count on me or Beth to attend every cruise. This boater could have easily gone into cardiac arrest if he did not realize his own symptoms, he was alone, or we weren't there telling him to lay down. Having an AED is a "no brainer!" We cannot simply count on help

arriving in a timely fashion when cruising out or being at a club function. This is a fact of life we can no longer ignore. Recently there was a cardiac arrest at a PICYA function at Loch Lomond Yacht Club. There was an AED there and it was successfully used. The patient survived and had pulses back before the Paramedics arrived.

The new AEDs such as my Zoll provides the users with CPR feedback verbally and with a graph. It will tell the user if the CPR is too fast or too slow. It will even tell the user if the depth of compressions is not deep enough.

The unit will even walk you through what to do. Learning hands only CPR is easy as watching Kevin Jeong (Hangover Movie Fame, Mr. Leslie Chow & real-life Doctor) teach you how to do it through several videos available on Youtube. No need to breath for someone or check for pulses. This is basic stuff now intended to get more people involved without the fear. You are all protected by the good Samaritan law. So please get involved and support the idea of our club purchasing an Automatic External Defibrillator (AED).

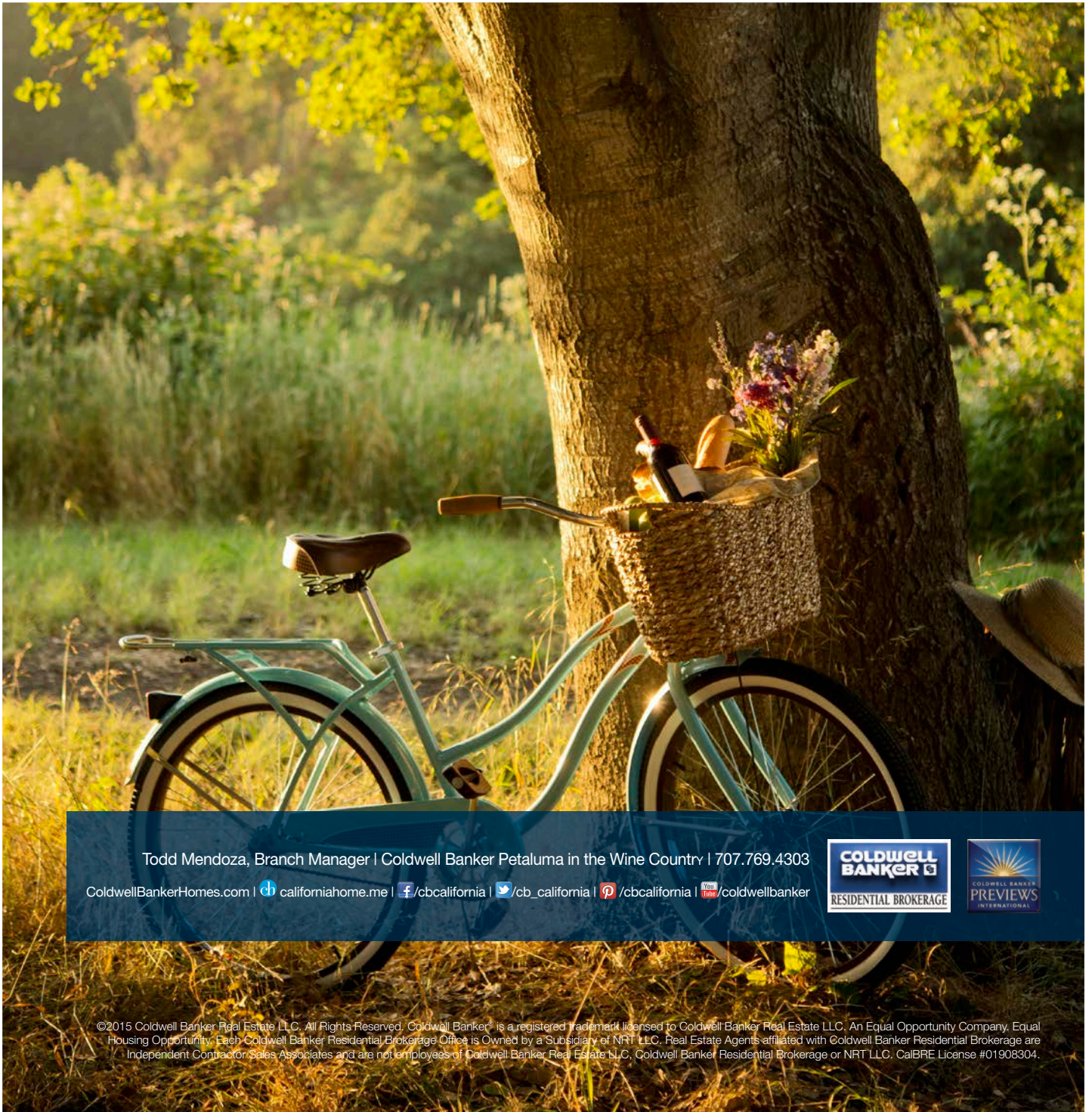

# Dredge Pledge Delivered



Nearly 100 club members and local residents turned out in force on August 2nd above the Petaluma Yacht Club dock to show their support for a long-awaited dredging of the river. Congressional Representative Jared Huffman and Petaluma Mayor Teresa Barret welcomed Lt. Col. John Cunningham, the new commander of the Corps' San Francisco District of the U.S. Army Corps of Engineers for a tour of the river.

Before departing on a short boat ride from the turning basin to the Petaluma Marina, Mayor Barrett gave Lt. Col. Cunningham a binder with nearly 3,700 'Dredge Pledge' signatures. The handoff took place as both stood on a tilted dock, one end raised by the growing mud bank beneath it.

The official party left the docks for the short voyage down to the Petaluma Marina at the well timed

lowest of low tides. The visit was to give the federal representatives a first-hand look at the silt-choked waters and the increasingly dire navigation conditions on the once busy 18-mile river. This was amply demonstrated when the party's boat became stuck in the mud no more than 100 yards into the turning basin. With judicious use of power, the boat struggled to free itself and continued down river, as many Dredge Pledge supporters cheered and waved banners from the river banks as the boat passed by.

Dredge Pledge supporters are hoping that the Petaluma River dredging project will make it to the Corps' 2020 work plan. After that, the city could take over maintenance, part of a now-nationwide trend as smaller ports pass out of federal hands to local control. 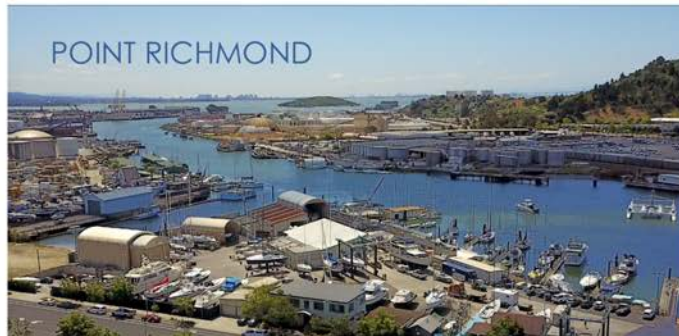

# From Tom's Galley

## Paprika Cumin Shrimp with Mushroom Herb Risotto



After marinating the shrimp, this is a quick dinner that can be done in about 20 minutes. It has a slight Mexican flavor with the paprika, cumin and green peppers. Serve with additional cilantro leaves and try the cilantro with the mushroom herb risotto for a nice flavor burst.

### Ingredients:

1 pound 21-25 shrimp, peeled	1 teaspoon onion powder
1 4-ounce can diced green chilies	1 package Trader Joe's Mushroom Herb Risotto
1 tablespoon smoked Paprika	2 tablespoons olive oil
2 teaspoons ground cumin	3 cups chicken broth
	2 teaspoons honey mustard
	Fresh cilantro leaves

### Method:

Peel shrimp and slightly butterfly bodies.

Drain liquid from diced green chilies and add to shrimp. Mix well to coat shrimp.

Add Paprika to shrimp and mix well.

Add cumin and onion powder to shrimp and mix to coat all shrimp.

Marinate shrimp for several hours.

Place 1 tablespoon oil in a medium saucepan over medium heat.

Saute risotto rice in hot oil for 2 minutes.

Add 3 cups chicken broth and seasoning packet from risotto.

Mix well and bring to a boil.

Reduce heat to simmer, cover and cook until broth is absorbed, stirring frequently, about 15 minutes.

Heat 1 tablespoon oil in a medium skillet over medium high heat.

When oil is hot, add shrimp and stir, moving and flipping shrimp constantly.

(Shrimp will cook very rapidly and only need to be opaque on both sides.

If overcooked they will become tough.)

To risotto add 2 teaspoons honey mustard and the diced green chilies. Mix well.

Place risotto on plate, top with shrimp and garnish with cilantro leaves.

*(The cilantro leaves add a nice flavor when eaten with the risotto.)*

Serves 4

*These recipes have been created and developed by PYC member, Staff Commodore and chef Tom Griffith and are designed to be prepared on board your boat, using only two burners or a BBQ. They can also be prepared at home for any family dinner.*

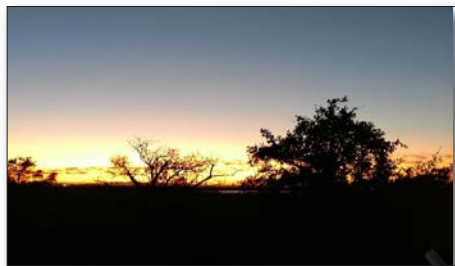
